Position: Scaffolding Supervisor

Location: Runcorn-based

Job type: Full time

Overview of the role

Scaffold Erection Services (SES) is part of Denholm Industrial Services Limited. We have an opportunity for an experienced Scaffolding Supervisor to join the SES team, based at our Runcorn office. The successful candidate will be responsible for the overall supervision of scaffolding personnel to achieve contracted arrangements for the erection and disassembly of scaffold and access structures in line with TG:20, system scaffolds and formal Design Guidelines. The Scaffolding Supervisor will also be required to follow company management system arrangements for health, safety, quality and environmental issues, both generally and as included within each project plan. The role involves the supervision of all scaffolding personnel assigned to the project that are involved in the logistics, loading, unloading, erection and dismantle and return of scaffold components and structures.

Role responsibilities

- Perform supervisory activities in accordance with the guidance specified in the relative project documents, including Inspection, Method Statement, drawings, appropriate industry standards (NASC Guidance) and reporting formats.
- Ensure the make-up of the Scaffold Team squad consists of appropriately qualified personnel and the relevant ratio of advanced scaffolders to basic scaffolders for the structures involved.
- Ensure that scaffold materials are stored and handled in accordance with the manufacturer's requirements and component type traceability is maintained and used.
- Carry out a pre-work survey of the work area to confirm client instructions, area restrictions, access and egress arrangements, materials quantity and plant requirements.
- Supervise scaffolding personnel to ensure operatives and support personnel carry out their works to support the contracted scaffolding requirements.
- Ensure completed scaffold structures conform to project specifications.
- Ensure client 'Acceptance and Handover' of scaffold structure is carried out.
- Monitor scaffold inspection feedback and recommend improvements.
- Ensure authorisation tags are installed or removed to reflect scaffold status.
- Prepare daily reports in agreed formats for the status of work and progress.
- Take part in supporting internal or third-party audits of the Company's quality control system.
- Arrange for timely inspection of the scaffold structure on completion of each works stage or phase and resolve any non-compliance issues.
- Liaise with client representatives on progression of the works and reporting output.
- Encourage best practice in all involved work disciplines and particularly with regard to health and safety and environmental issues.
- Carry out 'Start of Shift' briefings with the workforce, including communication of all COSHH and Risk Assessment information relating to the planned worksopes, where applicable.

- Attend 'Planning and Progress' meetings with the operations team to discuss health and safety, manpower resources, equipment, material and any other issues.

Accountability

The Scaffolding Supervisor reports directly to the Senior Supervisor on a daily basis and oversees work to ensure all project issues meet planned arrangements and client / industry specifications.

Skills and experience

The successful candidate will have a background in scaffolding and will hold relevant industry certification to SMSTS, SSSTS and CISRS, as applicable. The successful candidate will also have gained previous service industry experience in supervision, part of which relates to scaffolding works associated with multi-project activity.
